PostFinance Arena Stadium Regulations for SCB Eishockey AG

1. Validity

The stadium regulations apply to all championship matches and events which take place within the Post-Finance Arena (hereinafter referred to as the stadium) and associated outdoor areas (private property) as part of the Swiss Ice Hockey Association (SIHA) or the National League (NL) and SCB Eishockey AG or SCB Future AG.

2. Rights and obligations

2.1. Organizer

The organizer will do everything in its power to ensure the smooth running of the event and to take any necessary and reasonable security measures.

2.2. Spectators

All spectators who wish to gain entry to the stadium with a match ticket or a season ticket, regardless of whether these are paid for or obtained free of charge, shall be subject to the stadium regulations and must agree to comply with the provisions of the stadium regulations. The same applies to participants at other events which can be attended without purchasing a ticket. Furthermore, spectators agree to comply with all instructions given by security staff.

3. Stadium rules

3.1. Access rules

- Any person wishing to gain entry to events in the stadium must be in possession of a valid ticket. The ticket is only valid for the corresponding section.
- Spectators must undergo an entry check. Any person refusing a check will not be admitted.
- Any person carrying prohibited and/or dangerous items will be denied entry to the stadium, unless they voluntarily hand over these items together with their personal details at the entry check. Confiscated items will be returned at the end of the event, within 15 minutes of the event ending. An exception to this are items which are illegal to carry or to possess. These items will be handed to the police together with the owner's personal details. The following items are considered prohibited and/or dangerous: Glass bottles, PET bottles and cans, weapons of all kinds, laser devices, fireworks of any kind. This list is not exhaustive and the relevant legislation applies.
- The organizer has a legal right to refuse entry into the stadium to any undesirable person. An undesirable person shall particularly be anyone who is un-

der the influence of alcohol or drugs or is in possession of an entry ban, as well as any person exhibiting violent or inflammatory behaviour or who is known for such behaviour.

3.2. Security regulations

- Spectators are requested to contribute to the success of the event, to behave as fair sports fans and especially to refrain from rowdy behaviour.
- Instructions given by anyone in authority and the security officers of SCB Eishockey AG and/or SCB Future AG must be followed immediately.

3.3. Other rules of behaviour

- Smoking is prohibited in the stadium during events.
- Excessive consumption of alcohol is prohibited.
- Sound and picture recordings of any kind are strictly prohibited.
- Firecrackers and flares of all kinds are prohibited.
- The throwing of objects onto the ice surface is prohibited.

4. Video surveillance

For security reasons, spectators are filmed using video cameras. The recordings are kept securely. They serve as evidence in case of an incident and may be made available to the investigating authorities. When an event that is recorded by video camera passes off without incident, the recordings are deleted within a reasonable period of time in accordance with applicable legal provisions.

5. Sanctions following infringement of stadium regulations

Spectators acknowledge that if they fail to comply with these rules, they will be ejected from the event without compensation and be removed from the stadium. The organizer has a legal right to issue a stadium ban (entry ban) or to involve the police at any time, if any person fails to comply with the stadium regulations. Violations or infringements of stadium regulations may also lead to legal proceedings at the relevant court in Berne. Furthermore, the organizers reserve the right to take additional measures to enforce and to maintain a stadium ban.

6. Liability of the organizer

The organizer assumes no liability for personal injury or material damage. Each spectator assumes the risk himor herself by attending an event in the stadium.
